

# Bursary & Scholarship Application Form 2017/2018

Newman Theological College offers bursaries and scholarships to new and continuing students enrolled in NTC programs and courses.

Newman Theological College bursaries and scholarships are awarded (for tuition only) on the basis of the following criteria:

- Financial need
- Involvement in NTC community (current students) and/or
- Involvement in the Christian community (new and continuing students)
- Qualities of leadership
- Academic performance

- a. Complete all parts of the application and answer all questions. If the question does not apply to you, indicate "N/A" (not applicable).
- b. \*\*\*A letter addressing the following must accompany your application (300 words or less):
  - Why you are applying for this bursary (i.e. financial need).
  - Involvement in and service to the Newman Theological College community (current students).
  - Past and present experience of service in the Christian community and future plans for ministry, education or employment using your education at NTC.
  - Students applying for The Military and Hospitaller Order of St. Lazarus of Jerusalem MSGR. William Irwin Bursary must address their involvement and interest in ecumenical studies in the letter.
  - Other information you see as pertinent to this application.
- c. Regardless of the number of bursaries you apply for, only one bursary form needs to be filled out each year.
- d. Note: Incomplete or inaccurate applications will not be considered.
- e. Note: Seminarians, deacons and religious in needy dioceses or religious communities may apply for bursaries. Seminarians, deacons and religious students are required to include a letter from their bishop or superior stating that their diocese or religious order needs assistance in paying for the student's tuition.
- f. Mail, courier, e-mail or deliver your application to the Dean of Students (contact information on the last page of this form). Do not fax your application.
