- c. Regardless of the number of bursaries you apply for, only one bursary form needs to be filled out each year.
- d. Note: Incomplete or inaccurate applications will not be considered.
- e. **Note: Seminarians, deacons and religious in needy dioceses or religious communities may apply for bursaries. Seminarians, deacons and religious students are required to include a letter from their bishop or superior stating that their diocese or religious order needs assistance in paying for the student's tuition.**
- f. Note: Anglican seminarians and diaconal candidates are required to include a letter from their bishop stating that their Anglican diocese is unable to provide the necessary financial support for their candidates and are in need of assistance in the form of bursaries to help pay for their candidates tuition.
- g. Mail, courier, e-mail or deliver your application to the Dean of Students (contact information on the last page of this form). Do not fax your application.
